



Golf Cart Operating Regulations

All park visitors who wish to bring a personal golf cart to Johnson County Park must complete this application. **A fee of \$5 per cart is required. A non-transferable permit sticker will be issued to you upon approval of this application.**

Carts must display the permit sticker in a **VISIBLE** area. If you do not want adhere the sticker to your cart, that is ok, but it must be visible.

Cart operators must comply with all traffic regulations and speed limits. Carts without headlights are not permitted to operate after dark.

ALL operators must have a valid driver's license and must have it with them while operating the cart.

Carts are only permitted on paved/gravel roadways and should not cut through fields, cut through ditches, or run on trails. At no time are carts allowed to drive into the amphitheater, on the playground, basketball court or on the Equine XC Course without permission of the park management for a specific event.

Open display or use of alcohol while operating golf carts is not allowed.

Carts may not carry more than the number of passengers for which they were designed. Riders **MUST** remain seated at ALL times. No lap sitting and no sitting or standing in the baggage rack.

Some park and park associated events may not allow entry by golf cart.

Cart permits are only valid for Johnson County Park roads. If you leave the park you may be in violation of other military, state and local laws. (This includes 650S to the POW Chapel, etc.) It is **YOUR** responsibility to know where you are. If you have any questions, please see the park office.

Carts used in a reckless manner or violating park cart regulations will result in possible suspension of golf cart privileges indefinitely. This will be left up to Park Staff and Camp Host discretion.

If you are caught operating a cart without a permit, you will be asked to obtain one immediately or trailer the cart until one is obtained. Unauthorized vehicles are not allowed to operate in the park without a permit.

Types of carts allowed: ONLY Gas/electric golf carts are allowed. Engines may not exceed 14 HP. Stock mufflers or equivalent are required.

Not allowed: ATVs, UTVs, Side by Sides, Four Wheelers, RZR's and the like. Basically, anything that is not a gas/electric golf cart. ☺



FAQS

If I am only coming to stay for one night, do I still need a permit?

Yes. All carts on park property will need a permit if they are going to be operated outside of the Hoosier Horse Park.

So I can't bring my...???

If you are uncertain if your cart type is allowed, please check with the park office for clarification.

How long is the permit good for?

Permits are valid for the season it is purchased in. Permit stickers change colors every year.

I can let my 14 year old drive, right? They drive at our property/home, so why not?

No, you must only have licensed drivers operating your cart at any time. Learner's permits **DO NOT** count. While we know this is a difficult policy, it must be followed for everyone's safety.

Can I put my permit sticker on someone else's cart?

No. Each permit sticker is specific to each cart. If you transfer a permit sticker to another cart your permit will be revoked.
